PURPOSE

The purposes of our review were (1) to determine the allowability of the costs claimed under the ARC grant, (2) to determine if the grant objectives were met and (3) to determine the current status of the project.

SCOPE

Our survey included procedures to review costs incurred and claimed for reimbursement under the grant, as well as costs claimed as matching funds. The period of performance for the grant was September 1, 1999 through June 30, 2001. We reviewed the grantee's reports, examined records, and held discussions with grantee officials in Birmingham, Alabama, on April 20, 2001. As a basis for determining allowable costs and compliance requirements, we used the provisions of the grant agreement, Office of Management and Budget (OMB) Circulars A-21 and A-110, and the ARC Code. Audit work was performed in accordance with Government Auditing Standards.

BACKGROUND

ARC Grant AL-13244 was awarded to the Jefferson State Community College to provide funds for the addition of manufacturing technology curriculum to its course offerings. The project includes the purchase of automated manufacturing equipment by the Center for use in teaching credit and non-credit classes in manufacturing technology. Additionally, the Center will expand the educational programs offered by the Local Government Leadership component of the center.

The total project costs was estimated as \$479,030. The ARC grant was for \$200,000 (42%). The grantee was to pay or cause to be paid matching contribution of \$279.030 (58%).

RESULTS

Financial Review

During our visit, we reviewed the grantee's accounting records, including invoices and supporting documentation for a sample of grant and matching costs charged to the project. Total claimed costs were supported by the grantee's accounting records and no deficiencies were noted as to the allowability of the expenses or the adequacy of the documentation for the expenditures we reviewed.

The grantee's final reimbursement request, dated September 25, 2000, claimed total project costs of \$471,576, of which included grant costs of \$200,000 (42%) and matching costs of \$471,576 (58%). At that time, all of the equipment had been purchased, however, the facility was not ready for the installation of the equipment, and the grantee was not able to finalize the project and an extension was granted. Therefore, the grantee was reimbursed \$180,000, and the balance of \$20,000 due pending installation and receipt of the final report.

At the time of our visit, the equipment was installed and the grantee will be submitting their final report. Documentation shows the grantee has met their required non-federal match.

Program Review

We were given a tour and demonstration of the various technological and manufacturing work stations, which were very well laid out and impressive. The instructor stated he has employers waiting to hire the graduates. The grantee has successfully completed the tasks as required in the grant agreement.

However, OIG Report 01-37(H) notes that the Jefferson County Board of Education distance Learning Project had with project completion and equipment utilization delays similar to those reported in 01-21(H), Elmore County Telecommunications Project. Our recommendations emphasized timely project completion or alternative actions to utilize the equipment. For future projects of this type, control should be exercised to preclude equipment purchases substantially prior to other key project requirements being met.
