PURPOSE

The purposes of our review were (1) to determine the allowability of the costs claimed under the ARC grant, (2) to determine if the grant objectives were met and (3) to determine the current status of the project.

SCOPE

Our survey included procedures to review costs incurred and claimed for reimbursement under the grant, as well as costs claimed as matching funds. The period of performance for the grant was September 9, 1998 through October 31, 2000. We reviewed the grantee's reports, examined records, and held discussions with grantee officials in Birmingham, Alabama, on April 26, 2001. As a basis for determining allowable costs and compliance requirements, we used the provisions of the grant agreement, Office of Management and Budget (OMB) Circulars A-87 and A-102, and the ARC Code. Audit work was performed in accordance with Government Auditing Standards.

BACKGROUND

ARC Grant AL-13143 was awarded to the Birmingham Regional Planning Commission (BRPC) to provide funds to establish a planning and design center for the execution of regional strategic plans. BRPC has proposed a consortium of professional resources that would provide objective, cost-effective, and professional services. The consortium would include BRPC, the Auburn University Center for Architecture and Urban Studies, and Region 2020 Inc.

The total project costs was estimated as \$250,000. The ARC grant was for \$180,000 (72%). The grantee was to pay or cause to be paid matching contribution of \$70,000 (28%).

RESULTS

Financial Review

During our visit, we reviewed the grantee's accounting records, including invoices and supporting documentation for a sample of grant and matching costs charged to the project. Total claimed costs were supported by the grantee's accounting records and no deficiencies were noted as to the allowability of the expenses or the adequacy of the documentation for the expenditures we reviewed. However, there does exist a lack of separation of duties within the accounting process, as the same employee is involved with the receivables, payables and the monthly bank reconciliation. Although there is some oversight it does present an internal control risk. The grantee has agreed to address the situation.

The grantee's final reimbursement request, dated February 27, 2001, claimed total project costs of \$250,000, of which included grant costs of \$180,000 (72%) and matching costs of \$70,000 (28%). The grantee appears to have met their required match.

The grant ended October 31, 2000, but the final report was delayed to ensure complete information was collected from the various entities involved with the project. The final report dated April 4, 2001, was received and the grant was closed on April 11, 2001.

For future projects of this type, control should be exercised to preclude equipment purchases substantially prior to other key project requirements being met.
