<u>PURPOSE</u>: The purpose of our review was to determine if (a) the total funds claimed for reimbursement by Lake Cumberland Area Development District for its Lake Cumberland Regional Justice and Victims Advocacy Project were expended in accordance with the ARC approved grant budget and did not violate any restrictions imposed by the terms and conditions of the grant; (b) the accounting, reporting and internal control systems provided for disclosure of pertinent financial and operating information; and (c) the objectives of the grant have been met.

BACKGROUND: ARC awarded Grant Number CO-12265-95-I-302-0803 to the Lake Cumberland Area Development District for the period October 1, 1995 through September 30, 1997. Total grant funding was for an amount not to exceed \$100,000, or approximately 77 percent of actual, reasonable and eligible project cost, whichever was less. ARC required that the grant be matched with \$30,000 or 23 percent in cash, contributed services, and in-kind contributions, as approved by ARC. ARC made six advance/progress payments totaling \$100,000.

The purpose of this grant was to establish a Regional Justice and Victims Advocacy Council of judges, prosecutors, public defenders, law enforcement officers, social service agency members and private citizens who are interested in providing professional counseling for victims of child abuse, domestic violence and crime against the elderly. The service will be available through a 24-hour toll free number. The council will work with existing state and local social service agencies to coordinate services and provide a comprehensive victims advocacy program. The following specific tasks were to be performed:

- 1. Establish the Regional Justice and Victims Advocacy Council [the Council, once established, will develop and enter into memoranda of agreement with appropriate federal, state, and local social service agencies to coordinate services and to clearly define roles and responsibilities to ensure non-duplication of services];
- 2. Organize a team of volunteers consisting of local medical and lay people in each county in Grantee's area; and train these volunteers to assist victims of crime;
- 3. Establish a 24-hour toll free 800 number;
- 4. Counsel victims about their right to protection under existing laws;
- 5. Establish an emergency shelter program for victims;
- 6. Provide other services to victims, such as JTPA job training, aging and homecare services, and housing assistance, from programs currently provided by Grantee or through referrals; and
- 7. Evaluate the project.

SCOPE: We performed a program review of the grant as described in the Purpose above. Our review was based on the terms of the grant agreement and on the application of certain agreed-upon procedures in accordance with the ARC, OIG Review Program. Specifically, we determined if the tasks listed above had been performed, if the accountability over ARC funds was sufficient as required by the applicable Office of Management and Budget (OMB) Circulars, and if the Lake Cumberland Area Development District had complied with the requirements of the grant agreement. In addition, we discussed the program objectives and performance with Lake Cumberland Area Development District personnel. Our results and recommendations are based on those procedures.

<u>RESULTS</u>: The following results were based on our review performed at the Grantee's offices in Russell Springs, Kentucky on March 17 through 19, 1999.

A. Incurred Costs

The Grantee claimed total program costs of \$130,000, of which they claimed direct reimbursable costs from October 1, 1995 through September 30, 1997 of \$100,000. We reviewed the direct and in-kind costs incurred and determined that, in general, the funds had been expended as reported. However, we identified \$30,000 in matching funds that could not be supported and \$2,277 in direct reimbursable costs that could not be supported. In addition, we noted that one quarterly progress report out of eight were not submitted as required and the final report was never submitted. These issues are discussed below.

1. <u>Matching Costs Not Supportable</u>

Lake Cumberland Area Development District was required to match \$30,000 or 23% in cash, contributed services, and in-kind contributions under the Regional Justice and Victims Advocacy Project. Upon our review of correspondence attached to the original grant application, we found indications that \$20,000 had been pledged by the applicant and \$10,000 in program income was to be generated from fines and forfeiture system. However, Lake Cumberland Area Development District claimed that Bethany House, a crisis shelter operated by the Christian Appalachian Project located in Somerset, Kentucky was the provider of the matching costs. Lake Cumberland Area Development District had no support for the cost other than a letter indicating that the matching costs had been provided by Bethany House.

ARC Grant Administration Provisions, Article A10 Records Requirements (4) Records of Contributed Services. States:

"Contractor shall maintain custody of time records, payrolls, and other data, as appropriate, to substantiate all services reported to the Commission as Contributed Services under this contract."

2. General Ledger Did Not Support \$2,277 Of Costs Claimed

Lake Cumberland Area Development District claimed reimbursable costs from October 1, 1995 to September 30, 1997 of \$100,000 for the Regional Justice and Victims Advocacy Project. We reviewed the costs as recorded in the general ledger and found total costs incurred of \$97,723. The difference of \$2,277 in cost claimed and reimbursed was never expended under the grant award.

ARC Grant Administration provisions, Article A10 Records Requirements (3) Records of Disbursements. States:

"All disbursements from the contract account shall be for obligations incurred, after the effective date, in the performance of this contract, and shall be supported by contracts, invoices, vouchers and other data, as appropriate, evidencing the disbursements."

RECOMMENDATIONS:

- 1. We recommend that ARC require Lake Cumberland Area Development District submit additional documentation to support the \$30,000 in matching funds claimed under the grant award.
- 2. We recommend that ARC require the Lake Cumberland Area Development District to return the \$2,277 in unused ARC funds for credit against the grant award.

B. Internal Controls

Quarterly and Final Reports Were Not Submitted to the ARC Project Coordinator

The Grantee did not prepare and submit one out of eight quarterly progress reports to the ARC Project Coordinator as required by the grant agreement. In addition, the final report on the project was never submitted to the ARC Project Coordinator.

Grant Agreement Number CO-12265-95-I, Article 2-8.1 Progress Reports. states:

"Grantee shall prepare and submit to the ARC Project Coordinator, in three copies, quarterly progress reports indicating the work accomplished under this agreement to date, any problems encountered and ameliorative actions taken, and a forecast of work for the next report period."

Grant Agreement Number CO-12265-95-I, Article 2-8.2 Final Report. states:

"(1) <u>Draft Contents</u>. Within one (1) month after the period of performance, Grantee shall prepare and submit to the ARC Project Coordinator for approval, three copies of a draft final report of all work accomplished under this agreement including recommendations and conclusions based on the experience and results obtained."

RECOMMENDATION:

We recommend that ARC require Lake Cumberland Area Development District to submit a final report on the project.

C. Program Results

Our review of the Lake Cumberland Area Development District Regional Justice and Victims Advocacy Project indicated all specific tasks identified in the grant, and summarized above, had been achieved.

DISCUSSION:

We discussed these issues with the Grantee's management during the exit conference held on March 25, 1999. Management responded by stating it generally agreed with the findings and recommendations. Management stated that it would obtain support for the reported match and had no problem returning the unused funds to ARC.

OTHER:

We provided a copy of the draft report to the Lake Cumberland Area Development District management on April 12, 1999. Management responded to our findings and recommendations as

follows:

Finding Number 1 - Since the draft report was received, we have obtained a statement from the Bethany House including numbers served by the program, an average length of stay by the participants and the average cost per day to serve each participant. This statement includes a children count of the family served and the cost includes room, meals, transportation, clothes, medical and related expenses. The actual cost incurred exceeded the \$30,000 claimed.

Finding Number 2 - The financial report was a pre-audit report and during the audit some charges were found to be charged to the wrong category. With adjusting entries to correct the charges a \$2,277 balance existed in this program and the District will return said amount to ARC upon request by the funding agency.

Internal Controls - The one quarterly report was due at the 12 month period. We had requested a time extension on the project and that request was under consideration. At the time, we did not know whether to submit a quarterly or a final report. We were awaiting an ARC decision on our extension request, when the extension was granted it was well past the quarter and the report was simply forgotten. The final report was submitted in the wrong format. The final report has been corrected, placed in the proper format, and is included in this response.

ADDITIONAL COMMENTS:

We consider Lake Cumberland Area Development District's response to finding number 2 and internal controls as adequate. However, the support for the match may not be adequate. Lake Cumberland Area Development District's application for ARC funds indicated that the match would be provided from area court fines and penalties. We found no evidence that any matching funds were received from the courts for the purpose of completing this project. In addition, we found no approval from ARC indicating that the matching contribution could be provided by Bethany House.

ADDITIONAL RECOMMENDATION:

We recommend that ARC require Lake Cumberland Area Development District to request approval from ARC to use the matching funds provided by Bethany House rather than those that were to be provided by the local courts.

REVISED ANNUAL REPORT

The Lake Cumberland Regional Justice Victim's Advocacy Council held an organizational meeting on Thursday, October 26, 1995 at the Lake Cumberland Area Development District Conference Room in Russell Springs, Kentucky and Judge/Executive Charlene King was appointed Chair of the Council. See attached council member list. The Council met the second Monday of each month at 7:00 pm with speakers from different areas related to domestic violence and crime. Speakers included Travis Fritsch, an independent consultant and domestic violence specialist. She had previously served as Staff Assistant and Victim Advocate in the Office of Kentucky's Attorney General. She was staff consultant to the Attorney General's Task Force on Domestic Violence Crime that produced nationally recognized laws, protocols and programs. Teri Faragher of the Governor's Domestic Violence Prevention Board spoke to the council regarding the Domestic Violence Protocol, which outlines the roles and responsibilities of the agencies dealing with domestic violence. Shannon Meddings, Legal Justice Coordinator of The Center for Women and Families of Louisville, Kentucky spoke to the council regarding the network of Spouse Abuse Shelters through the Area Development District. She also updated the council on laws which the legislature had recently passed in relation to domestic violence including the VINE (Victim's Identification and Notification Everyday) system. Virginia King a victim of domestic violence who continues to live in hiding from her abusive ex-husband spoke to the council about how life really is after living in domestic violence for several years before leaving the abusive situation. Janie Webster Leach of the ACT (Abused Children Talk) organization told of her life and the life of her daughter in an abusive situation. Ms. Leach and her daughter had to leave the United States in order to keep her four year old daughter away from an abusive and AIDS infected father who was a medical doctor teaching in California. Only upon his death were they able to return to the U.S. and have legal proceedings dropped. Georgia Edwards of the Kentucky State Police spoke to the group regarding the LINK system and it's operation in the state of Kentucky. Charlotte Tribble, Director of Bethany House Spouse Abuse shelter informed the group of the daily operations and programs of the agency. Speakers of other areas relative to domestic violence were also included.

The Lake Cumberland Area Development District had a contract with Bethany House Shelter to reimburse them for the crisis lines into the facility. Copy of contract is attached. One of the crisis lines is an 800 number available to the state of Kentucky. Attached also is a Bethany House brochure showing the 800 number and a page from the local phone directory with the number highlighted. Included is a cover sheet of the billing from Bethany House showing the amount reimbursed for the crisis lines. The ADD also provided reimbursement for travel for the pick up and delivery of victims to Bethany House shelter. The Bethany House Shelter has been supported by the ADD and recently received approval for assistance in developing transitional housing for domestic violence victims upon their leaving Bethany House. December 1996 reports show Bethany Housing service 206 "Total Residents" year-to-date with "Resident Days" being 2069. August 1997 reports show "Total Residents" year-to-date as 79 with "Resident Days" year-to-date showing 635. Crisis calls for 1996 were 119 and as of August 1997 crisis calls were 101 year-to-date.

Through the availability of ARC funds the Lake Cumberland ADD has been able to provide staff time and assistance to prepare technical competitive applications for funding of transitional housing units for victims of domestic violence. Projects approved include 16 units of transitional housing for Kentucky Baptist Homes for Children and Bethany House Shelter: \$1,172,000 for continuum of care and home funds. \$85,000 was approved for two units of transitional housing in Russell County. This was made possible through the Kentucky Housing Corporation Affordable Housing Trust Funds. This will be the first opportunity within the Lake Cumberland Region for victims of domestic violence to have access to transitional housing assistance.

Housing assistance has also been provided to victims, by referral from the Lake Cumberland ADD, to the Lake Cumberland Housing Agency. Housing was also made available to a victim who is a convicted felon (she had her abuser killed). The victim was living in a basement apartment belonging to her brother. The apartment had no central air conditioning or heat and due to her asthma, emphysema and lung cancer the doctor would not let her leave the hospital without replacement housing. She then moved to a room above the brother's apartment and installed one window air conditioner. She was confined to one room (just as she had been in prison for ten years). For a period of time it was necessary to get in the car and drive around the house to the basement apartment in order to have access to a bathroom. After a bathroom was installed upstairs, she had to wash dishes in the bathroom sink. After working with the county judge, mayor and public housing, Ms. Witherspoon helped to obtain public housing for the victim. The victim has now had lung and kidney surgery and is greatly improving in her health status. She plans to attend the Kentucky Tech Vocational School in the fall quarter to get an education, obtain employment and get off the welfare rolls. She is a faithful member of the support group and has helped many other women in domestic violence situations. She recently conducted a candlelight vigil for domestic violence victims, at the local fire station, with speakers from the State Attorney General's office and other survivors. It was well attended and very impressive.

LCADD with the assistance of the council organized and established support groups in all ten counties. A sample schedule of monthly meetings is attached. Most of the meetings were held in county libraries, a safe place for victims or survivors to attend without creating suspicions and creating more problems for themselves. A group of college students became involved in one county and did court monitoring, recruited donations for Bethany House and learned about domestic violence proceedings and victim's rights. A sample court monitoring report is attached. A local church donated a basement room for victims to stay in until Bethany House could arrive to pick them up and take them safely to Somerset.

As Director, Ms. Witherspoon spoke to different agencies including Interagency Councils, Head Start parents, church groups, Senior Citizens Groups, Christian Women's Fellowship Group, Somerset Community College Law Enforcement Class, State of Kentucky Health Services Department of Social Insurance and others regarding domestic violence statistics, symptoms, warnings, procedures and victim's rights. A Safety Plan was developed by LCADD staff and council and distributed to these and several other groups. A copy is attached. A Safety Plan for children was prepared and given to Head Start Parents for their children.

Ms. Witherspoon, Director, gave technical assistance to Scott County Sessions Judge Jamie Cotton and Kathy King, Administrative Director of Oneida, Tennessee in the development and opening of a Scott County Women's Shelter in Huntsville, Tennessee. See attached document.

ARC funds were used to create and provide a "silent witness project" in all ten counties for Domestic Violence Awareness. Ms. Witherspoon designed a silhouette of a female and 20 seven-foot tall, red silhouettes were placed in county courthouses, city halls, libraries, schools, etc. to provide awareness of domestic violence. The silhouette carried a poster with the 800 number for assistance. Brochures accompanied the silhouettes for Bethany House Shelter and for "Crime Victims' Rights in Kentucky." Copies attached.

Through the Lake Cumberland ADD, JTPA educational assistance has been offered to domestic violence victims. The ADD provides financial assistance for books, tuition, travel and child care for victims who wish to attend school to further their education or get a GED. Assistance is available at Eastern Kentucky University, Richmond, KY; Lindsey Wilson College, Columbia, KY; Somerset Community College, Somerset, KY and Kentucky Tech Vocational School, Somerset, KY. Several children of the victims are currently attending classes at Somerset Community College and Kentucky Tech Vocational School in Somerset.

Many families of domestic violence have been assisted through the Family Preservation project by referrals from the Lake Cumberland ADD office. Families were required to have children but could obtain financial assistance (in all ten counties) on a one-time basis to help with car repairs to get a parent to work, clothes for a child, food, putting in a septic tank so the family could move to a trailer, paying an insurance premium on a vehicle so the parent could work,

paying an overdue rent bill and many other one-time situations.

The Lake Cumberland Regional Justice and Victims Advocacy Project has directly impacted over 35 council members, 2.5 professional staff members, and over 115 volunteers in the creation of a regional community awareness and intervention program. This project also directly impacted 290 victims and their children. 230 victims were indirectly affected by the project. Also, this program indirectly affected 135 volunteers who attended court and provided support to victims whether by phone, in person or in a group setting.

In summation, ARC funds has enabled the Lake Cumberland ADD to get this project to be recognized not only regionally but also on the state and national levels. The Lake Cumberland Area Development District, Inc., was recognized with an Innovative Award for its Regional Justice and Victims Advocacy Project. The presentation was made in Hilton Head, South Carolina at the Fall 1996 29th Annual Training Conference of the National Association of Development Organization, Washington, D.C. Copy attached.

On May 20, 1997 the Lake Cumberland Regional Justice & Victim's Advocacy Council received the State Commissioner's Award for Interlocal Cooperation. "For their ongoing cooperative efforts to improve the quality of life in the Commonwealth of Kentucky." by Paul E. Patton, Governor of Kentucky and Bob Arnold, Commissioner.

It is with regret that due to a lack of local, regional and state resources that the Lake Cumberland Area Development District had to discontinue this worthy project on September 30, 1997.

Lake Cumberland Regional Justice Victims Advocacy Council Organizational Meeting October 26, 1995

On Thursday, October 26, 1995, the organizational meeting of the Lake Cumberland Regional Justice Victims Advocacy Council was held at 6:00 p.m. central time in the conference room of the ADD offices in Russell Springs, Kentucky, with seventeen (17) members present. The meeting was called to order by Judge/Executive Charlene King, Chairman, with explanations of how Judge King was appointed to the Chair of the Council, and everyone was asked to introduce themselves.

Mr. Bennie Garland, Director of Programs and Planning at the Area Development District, briefly reviewed the agency's regional justice victims advocacy application and considerable discussion took place concerning the causes and possible solutions to the domestic violence problem within the region. Mr. Garland also distributed a domestic violence survey for everyone to complete and turn in at the end of the meeting.

Regarding the operational process of the Council, a committee was appointed, consisting of Mr. David Cross, Mr. Tom Weddle, and Ms. Connie Phillips, and charged with the tasks of reviewing the necessity of by laws or an operational manual, recommending someone to serve as vice chairman, and establishing a regular meeting date.

With no further business the meeting adjourned at approximately 7:30 p.m.

Initial Report for Court Watch Project

Burkesville, KY

July 3, 1996 I attended the regular weekly session in Judge Steve Hurt's courtroom. I was watching for any case pertaining to a domestic dispute, divorce, spousal violence, restraining orders etc.

I witnessed three relevant cases. First, a burly and sunburned man was called forward for non-payment of child support. The plaintiff came forward from another part of the room, and positioned herself so that the county attorney was between her and the defendant at all times. For a brief moment an argument ensued between the two regarding him recently showing up drunk at the hospital to visit a relative. The judge ordered both to be silent.

The man plead guilty to non-support. The judge then explained that he was in a catch-22 position: if he sentenced him to jail time, he would be less able to pay support payments. If he fined him, he would also be less able to make payments. He ordered a 30-day sentence, probated if the man made scheduled payments in the future. There was discussion about that schedule.

The next relevant case called was a mousy young man, who had been sitting next to someone who might have been his mother. I heard the judge tell him that the protection? restraining? order had not been served, because "we haven't caught up with her yet. If we don't catch her within the next week, this order won't be valid anymore. So we are still aiming to find her soon." The young man quietly signed paperwork and left.

The third case was a man called before the bench for fourth degree assault. He seemed frightened to be facing the judge. There was no plaintiff present. The judge and the county attorney discussed something I could not hear for a few sentences. Then I heard the Judge order that current charges would be dismissed if there were no further complaints within the next 90 days. The man's countenance visibly shifted and he seemed very relieved, sort of ran out.

I did not speak to the judge, though we acknowledged each other with a wave and a smile. I intend to talk with him next time.





CRIMINAL JUSTICE STEPS



IF YOU ARE A VICTIM OF OR A WITNESS TO A CRIME

- Call law enforcement immediately
- Give law enforcement as much information as you can about the crime or crimi-
- Obtain the report number and the officer's name to use when communicating with law enforcement about the case
- Cooperate with authorities. Remember, the only way to reduce crime and aid in arrest and conviction is with your assistance.
- Call the prosecutor's office if you have a change of address or phone number

THE VICTIMS' BILL OF RIGHTS

The provisions of the Victims' Bill of Rights apply to victims of crime or next of kin who have suffered direct or threatened physical, financial or emotional harm as a result of the commission of a homicide, robbery, rape, assault, sodomy, kidnapping, burglary I and II, sexual abuse, wanton endangerment, criminal abuse or incest. If the victim is a minor or has special needs, an advocate may be appointed by the court.

Crime victims have the right to be:

- informed of emergency services, crime victim compensation, community treatment programs and the criminal justice process
- notified when the accused is arrested
- informed about protection from harassment, intimidation and retaliation
- notified of important occurrences in their
- consulted on any plea bargain agreement
- assisted in contacting employers when prosecution requires much time away from work
- given back their property held as evidence as soon as possible
- heard by means of a written impact statement to the court describing the effects of the crime on the victim before sentencing of a defendant
- heard by means of a victim impact statement to the parole board and notified of any hearing on release
- notified by the Attorney General's Office if a conviction is appealed and of any decision by the court

PROSECUTOR'S ROLES AND RESPONSIBILITIES

Attorneys for the Commonwealth shall make a reasonable effort to ensure that victims and witnesses are promptly notified of scheduling changes that affect their appearance in court.

MEMORANDUM OF AGREEMENT

This agreement entered into this <u>lst</u> day of <u>April</u>, 1996 by and between the Lake Cumberland Area Development District, Inc., of Russell Springs, Kentucky, hereinafter referred to as the party of the First Part, and Bethany House Abuse Shelter, Inc., of Somerset, Kentucky, hereinafter referred to as party of the Second Part.

Whereas, The Party of the First Part is a recipient of a grant from the Appalachian Regional Commission for the purpose of establishing methods and procedures within the ten counties of the Lake Cumberland region consisting of Adair, Casey, Clinton, Cumberland, Green, McCreary, Pulaski, Russell, Taylor and Wayne Counties to more effectively assist victims of domestic violence; and

Whereas, The Party of the Second Part currently maintains and provides an emergency shelter for victims of domestic violence in Somerset, Kentucky and receives clients from all of the aforesaid counties of the Lake Cumberland Area Development District; and

Whereas, The Party of the Second Part has employed full time staff who are professionally trained to receive complaints from victims and referrals from various social service agencies for assistance in handling issues relating to domestic violence on a case by case basis; and

Whereas, It is advantageous to coordinate the services of the parties of the First and Second Part in order that the quality of services and the degree of confidentiality to those served be further enhanced,

NOW THEREFORE BE IT AGREED;

That the Party of the First Part will provide financial assistance to the Party of the Second Part in an amount not to exceed Three Hundred Dollars (\$300.00) per month for the establishment of a 24 hour, 7 days a week telecommunications system consisting of a 1-800 telephone "hotline" titled "Lake Cumberland Crisis Line" for referrals to be made and for assistance to be given by both parties of this agreement. Reimbursement will be given on a monthly basis with an invoice provided by the Second Party; and

BE IT FURTHER AGREED;

That the Party of the First Part will provide financial assistance to the Party of the Second Part in the amount not to exceed One Hundred Dollars (\$100.00) per month for the purpose of providing transportation assistance for victims of domestic violence within the aforesaid ten counties who are in need of emergency shelter. The rate for transportation assistance shall be twenty five cents (\$.25) per mile. Reimbursement will be given on a monthly basis with an invoice provided by the Second Party and

BE IT FURTHER AGREED;

That the Party of the Second Part shall provide to the Party of the First Part detailed monthly reports, provided by the Party of the First Part, relating to activities of this agreement. Said information will be protected by all applicable confidentiality laws and regulations. Said information will be used to gather stastical data and to assist victims in transitional activities that will help them to live a more productive and safe life.

This agreement shall be effective April 1, 1996 and shall terminate September 30, 1996. Subject to the availability of funding this agreement may be amended and extended by the mutual agreement of the parties hereto. Either party shall have the right to terminate this agreement by giving a written 30 day notice by certified mail.

In 1979-80, the Christian Appalachian Project (CAP) became deeply concerned about the "secret violence" of family violence, as did others in Kentucky. In February, 1981, Bethany House, a spouse abuse center was opened as part of the Family Life Center of Appalachia. In September, 1983, Bethany House moved to Somerset.

From its beginning, Bethany House has had a unique program of service to all members of domestic violence. Abused women and their children are provided with emergency shelter and counsel. Abusers are offered help in dealing with their problems.

Bethany House has a capacity of 20. In 11 it sheltered 30 women and 45 children. In 1991, that number was much higher with 143 women and 223 children served.


What is Bethany House Spouse Abuse Program? -- A crisis shelter operated by the Christian Appalachian Project for victims of spouse abuse and their children,

When was Bethany House founded?—Bethany House first opened in February, 1981 in the Cumberland Valley District. In response to the need in the Lake Cumberland District, C.A.P. relocated the shelter to Somerset, KY in August of 1983.

What is the purpose of Bethany House?—Bethany House seeks to contribute to the improvement of the Appalachian family by offering safe shelter for up to 30 days, food, clothing, transportation, marriage and family counseling referrals, legal referrals, crisis intervention, 24 hr. crisis line and individual and group counseling. These services are primarily for women and their children who are victims of domestic violence.

What is the staffing pattern at Bethany House?——Program Manager, Program Coordinator, Counselor (contracted through the C.A.P. Counseling Service), Case Worker, Outreach Worker, and five Resident Assistant's II. what is the Bethany House service area?—Bethany House services the Lake Cumberland Area Development District which includes: Adair Co., Casey Co., Clinton Co., Cumberland Co., Green Co., McCreary Co., Pulaski Co., Russell Co., Taylor Co., and Wayne Co. These counties are primary responstibility, however if space is available we will accept referrals from anywhere.
