**SUBJECT:** Financial Audit of USAID Resources Managed by Deloitte Consulting Limited in Tanzania Under Multiple Awards, June 1, 2023, to May 31, 2024 (Report No. 4-621-25-109-R)

This memorandum transmits the final audit report on USAID resources managed by Deloitte Consulting Limited (DCL) under the following awards: (1) 72062122C00002, USAID Afya Yangu (My Health) Southern project; and (2) 72062122CA00001, USAID Kizazi Hodari (Brave Generation) Southern project. DCL contacted with the independent audit firm KPMG, Dar es Salaam, Tanzania to conduct the audit. The audit firm stated that it performed its audit in accordance with International Standards on Auditing in conjunction with generally accepted government auditing standards. However, it did not have an external peer review program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on DCL's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate DCL's internal controls; (3) determine whether DCL complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, KPMG (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by DCL as incurred from Jun 1, 2023, to May 31, 2024; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to DCL's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures

Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) reviewed the indirect cost rate; and (5) reviewed the implementation status of the prior period recommendations. DCL reported expenditures of \$28,798,600 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and no instances of material noncompliance. In addition, although we are not making a recommendation for significant deficiencies and immaterial noncompliance instances noted in the report, we suggest that USAID/Tanzania determine if the recipient addressed the issues noted.

Accordingly, we are not making any recommendations.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated May 27, 2025.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) ("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
