**SUBJECT:** Closeout Audit of Knowledge Partner for Health Project, Managed by SWASTI Health Resource Centre in India, Cooperative Agreement 72038618CA00001, April 1, 2023, to January 31, 2024 (5-386-25-038-R)

This memorandum transmits the final audit report on Knowledge Partner for Health project managed by SWASTI Health Resource Centre (SWASTI) in India under cooperative agreement 72038618CA00001, from April 1, 2023, to January 31, 2024. SWASTI contracted with the independent audit firm, Kumar Mittal & Co. to conduct the audit. The audit firm stated it performed its audit in accordance with generally accepted government auditing standards (GAGAS). However, the audit firm disclosed that it did not have continuing professional education and external peer review programs that fully satisfy GAGAS requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on the recipient's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were mainly to (1) express an opinion on whether SWASTI's schedule of expenditures of USAID awards for the audited period were presented fairly, in all material respects; (2) evaluate SWASTI's internal controls related to the USAID-funded project; and (3) determine whether SWASTI complied with the award terms and applicable laws and regulations. To answer the audit objectives, the audit firm conducted a financial audit that covered costs of \$759,956 for the audited period.

The audit firm concluded that the schedule of expenditures of USAID awards presented fairly, in all material respects, project revenues and costs incurred under the agreement for the period audited. The audit firm did not identify any material internal control and any instance of material

noncompliance. The audit firm issued a management letter that had no material issues that required a recommendation.

The report does not include any recommendations for your action.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) (“commercial or financial information obtained from a person that is privileged or confidential”). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
