- **SUBJECT:** Food Distribution Program on Indian Reservations (FDPIR) and Commodity Supplemental Food Program (CSFP)

The Office of Inspector General (OIG) performed an inspection of the circumstances surrounding the oversight and enforcement of the FDPIR/CSFP food delivery contract. We focused our examination on the significant events that impacted USDA's ability to oversee and enforce the contract. We reviewed Departmental and contracting regulations and other published guidance. We interviewed Food and Nutrition Service and Agricultural Marketing Service program officials, visited the vendor's facility, conducted interviews with the vendor, and reviewed documentation pertaining to the awarded contract and costs resulting from the food delivery issues. This inspection was conducted in accordance with the Council of the Inspectors General on Integrity and Efficiency's *Quality Standards for Inspection and Evaluation*. This report contains sensitive content and is being withheld from public release due to privacy concerns.
