Report on the Qualitative Assessment Review of the Investigative Operations of Subject:

the Office of Inspector General for the Federal Election Commission

Dear Inspector General Ruge-Hudson:

We have reviewed the system of internal safeguards and management procedures for the investigative operations of the Office of Inspector General (OIG) for the Federal Election Commission (FEC) in effect for the period ended August 31, 2024. Our review was conducted in conformity with the Quality Standards for Investigations and the Qualitative Assessment Review Guidelines established by the Council of the Inspectors General on Integrity and Efficiency (CIGIE).

We reviewed compliance with the FEC OIG system of internal policies and procedures to the extent we considered appropriate. The review was conducted at the FEC headquarters office in Washington, D.C. Additionally, we reviewed five case files for investigations closed between September 1, 2022, and August 31, 2024 (see Attachment A).

In our opinion, the system of internal safeguards and management procedures for the investigative function of the FEC OIG in effect for the year ended August 31, 2024, is in compliance with the quality standards established by CIGIE and other applicable guidelines cited above. These safeguards and procedures provide reasonable assurance of conforming with professional standards in the planning, execution, and reporting of its investigations.
