The Office of the State Inspector General (OSIG) Directive 001, in accordance with *Code of Virginia* § 2.2-309, requires all executive branch state agencies and institutions with internal audit functions to submit to OSIG the following documents:

- Audit charter.
- Risk assessment.
- Annual audit plan.
- Most recent external quality assessment review.
- Audit reports.
- Special projects and investigations.
- Status of corrective actions.

Code of Virginia § 2.2-309 requires OSIG to coordinate and require standards for all executive branch state agencies and institutions with internal audit functions to ensure that the Commonwealth's assets are subject to appropriate internal management control. There are 31 executive branch agencies with an internal audit program.

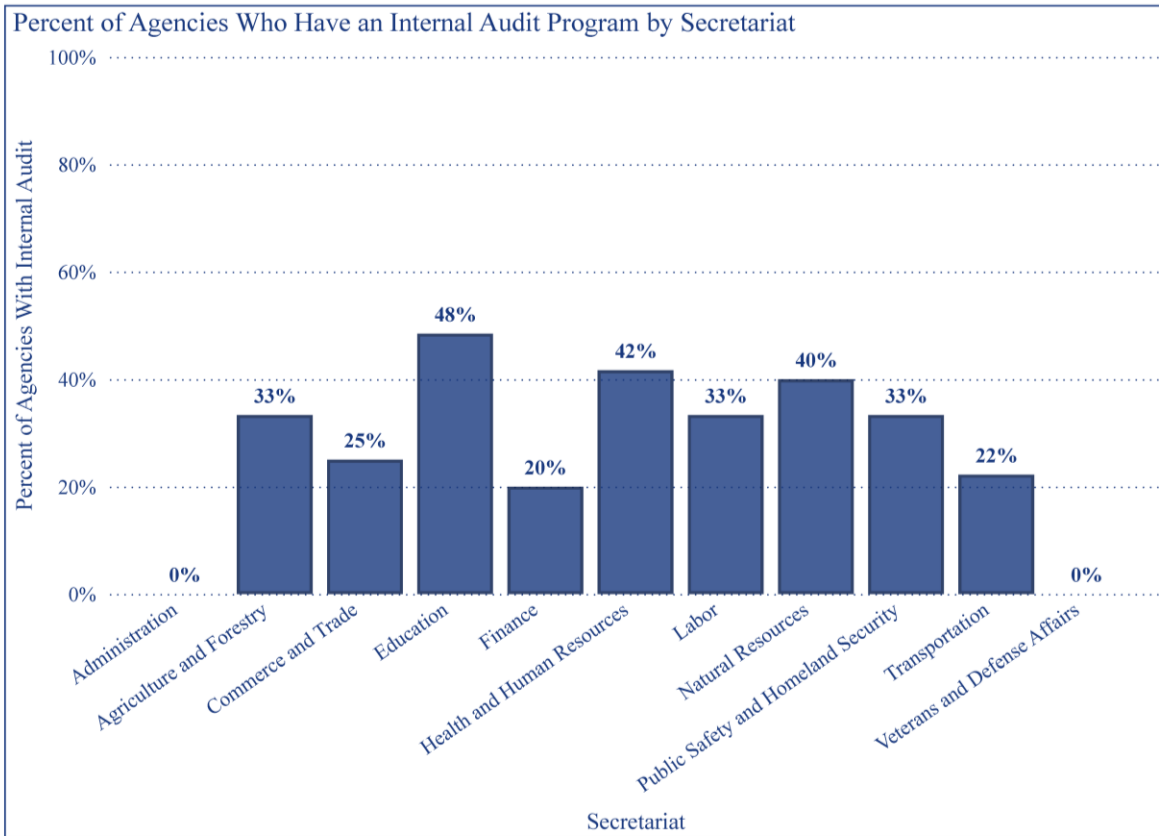
All of the agencies follow the Institute of Internal Auditors *Standards for the Professional Practice of Internal Auditing*. The Standards require the internal audit programs to go through an external assessment process every five years to ensure they are in conformance with all IIA Standards. The core documents that the IIA requires to be completed are the charter, risk assessment, audit plan and the quality assessment review. The following charts and graphs show internal audit programs by Secretariat, as well as whether a charter, audit plan, and risk assessment were submitted to OSIG, and whether a quality assessment review was performed during the last five years as required by IIA Standards.
