**SUBJECT:** Audit of USAID Resources Managed by Bio Carbon Partners Limited in

Zambia Under Agreement AID-611-A-14-00001, January 01, 2016, to

December 31, 2016 (Report No. 4-611-18-062-R)

This memorandum transmits the final audit report on USAID resources managed by Bio Carbon Partners Limited (BCP) under agreement AID-611-A-14-00001. BCP contracted with the independent certified public accounting firm Deloitte & Touche, Lusaka, Zambia to conduct the audit. The contract required the audit firm to perform the audit in accordance with generally accepted government auditing and USAID OIG Guidelines for Financial Audits Contracted by Foreign Recipients. <sup>1</sup>

The audit firm states that it performed its audit in accordance with generally accepted government auditing standards except that the audit firm did not have an external peer review because no such program is offered by professional organizations in Zambia. The firm stated also that it did not have a continuing education program. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on BCP's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>2</sup>

Our desk reviews are typically performed to identify any items needing clarification or issues requiring management attention. Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

The audit objectives were to (I) express an opinion on whether the fund accountability statement for the period audited, was presented fairly, in all material respects; (2) evaluate the BCP's internal controls; (3) determine whether BCP complied with award terms and applicable laws and regulations; (4) performed an audit of the indirect cost rate; and (5) reviewed the implementation status of the prior period recommendations.

To answer the audit objectives, Deloitte & Touche Zambia (I) audited the fund accountability statement for the award including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by BCP as incurred from January I, 2016, to December 31, 2016; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to BCP's ability to report financial data consistent with the assertions embodied in each account of the fund accountability statement; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the fund accountability statement; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. BCP spent \$4,269,960 in USAID funds during the audited period.

The audit firm concluded the fund accountability statement presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited except for \$107,807 in total questioned costs (\$40,503 ineligible and \$67,304 unsupported); twenty-three significant deficiencies in internal control; and nine instances of material noncompliance. However, six out of the nine findings on material noncompliance have been raised in the report on internal control.

To address the issues identified in the report, we recommend that USAID/Zambia:

**Recommendation 1.** Determine the allowability of \$107,807 in questioned costs (\$40,503 ineligible and \$67,304 unsupported) on page 13 of the audit report and recover any amount that is unallowable.

**Recommendation 2.** Verify that BCP corrects the twenty-three significant deficiencies in internal control detailed on pages 18 to 43 of the audit report.

**Recommendation 3.** Verify that BCP corrects the nine instances of material noncompliance detailed on pages 46 to 55 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision. We appreciate the assistance extended during the engagement.
