SUBJECT: Closeout Financial Audit of USAID Resources Managed by RECO Industries

Limited in Uganda Under Cooperative Agreement AID-617-A-12-00004,

July 1, 2016, to August 6, 2017 (Report No. 4-617-19-013-R)

This memorandum transmits the final audit report on USAID resources managed by RECO Industries Limited. RECO Industries Limited contracted with the independent certified public accounting firm Kisaka & Company (Kampala, Uganda) to conduct the audit. The contract required the audit firm to perform the audit in accordance with generally accepted government auditing standards (GAGAS).

The audit firm states that it performed its audit in accordance with GAGAS, except that the audit firm did not have continuing professional education and external quality control review programs that fully satisfied the requirements set forth in GAGAS. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on RECO Industries Limited's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. 1

The audit objectives were to (1) express an opinion on whether the fund accountability statement for the period audited, was presented fairly, in all material respects; (2) evaluate the RECO Industries Limited's internal controls; (3) determine whether RECO Industries Limited complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of prior period recommendations.

reviews are typically performed to identify any items needing clarification or issues requiring management attention. Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

To answer the audit objectives, Kisaka & Company (1) audited the fund accountability statement for the award including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by RECO Industries Limited as incurred from July 1, 2016, to August 6, 2017; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to RECO Industries Limited's ability to report financial data consistent with the assertions embodied in each account of the fund accountability statement; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the fund accountability statement; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of prior period recommendations. RECO Industries Limited reported expenditures of \$5,002,501 in USAID funds during the audited period.

The audit firm concluded the fund accountability statement presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm reported one significant deficiency in internal control and one significant deficiency reported in the prior period not yet resolved. The audit firm also determined that the unexpended fund balance at closeout to be remitted to USAID was \$192,533.

During our desk review, we noted several minor issues which the audit firm will need to address in future audit reports. We presented these issues in a memo to the controller, dated October 17, 2018.

To address the issues identified in the report, we recommend that USAID/Uganda:

**Recommendation 1.** Verify that RECO Industries Limited corrects the two significant deficiencies in internal control detailed on pages 25 and 27 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision. We appreciate the assistance extended during the engagement.
