SUBJECT: Financial Audit of USAID Resources Managed by West Africa Health Organisation Under Agreement AID-624-A-15-00001, January 1 to December 31, 2018 (Report No. 4-624-20-066-R)

This memorandum transmits the final audit report on USAID resources managed by West Africa Health Organisation (WAHO). WAHO contracted with the independent certified public accounting firm PricewaterhouseCoopers (PWC), Accra, Ghana, to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards (GAGAS). However, it did not have an external peer review that fully satisfied the requirements of GAGAS. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on WAHO's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the fund accountability statement for the period audited, was presented fairly, in all material respects; (2) evaluate WAHO's internal controls; (3) determine whether WAHO complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, PWC (1) audited the fund accountability statement for the award including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by WAHO as incurred from January 1 to December 31, 2018); (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to WAHO's ability to report financial data consistent with the assertions embodied in each account of the fund accountability statement; (3) identified the award terms and pertinent laws and regulations and determined

Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

which of those, if not observed, could have a direct and material effect on the fund accountability statement; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. WAHO reported expenditures of \$1,422,295 in USAID funds during the audited period.

The audit firm concluded the fund accountability statement presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited, but noted \$2,850 in immaterial ineligible questioned costs; no material weaknesses in internal control; and no instances of material noncompliance. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation. Nevertheless, we suggest that USAID/West Africa determine the allowability of the \$2,850 in ineligible questioned costs and recover any amount determined to be unallowable. In addition, although we are not making a recommendation for significant internal control deficiencies noted in the report, we suggest that the agency determine if the recipient addressed the issues noted.

During our desk review, we noted several minor issues which the audit firm will need to address in future audit reports. We presented these issues in a memo to the controller, dated May 5, 2020.
