Dear Congressman Jones,

On April 29, 2016, you wrote requesting information on the Department of Defense (DOD) Task Force for Business and Stability Operations (TFBSO) use of private "villas" in Kabul and other locations in Afghanistan. Specifically, you requested that SIGAR provide information on the cost, occupancy, and use of those villas. This letter provides our response to those questions.

To answer your questions—listed below by number—we searched the TFBSO hard drive DOD delivered to SIGAR on January 14, 2016, which DOD claimed contained all of its remaining electronic records on the task force. Additionally, we contacted all the agencies that performed contracting on TFBSO's behalf for the villas in Afghanistan and reviewed their contract documents. Furthermore, we contacted three contractors SIGAR identified as providing services at the villas: Triple Canopy, Defense Group Incorporated (DGI), and Muscogee Nation Business Enterprise (MNBE). We also contacted former contractor employees with knowledge of the use and operation of the TFBSO villas.

 The names and employment status (for example: TFBSO staff member, other government agency employee, contractor employee, or TFBSO guest or visitor) of all persons who stayed at these villas while they were leased by TFBSO, the purpose of their visit, and the duration of their stay.

After a review of the TFBSO hard drive, records from the relevant contractors, and contract documents, we were unable to definitively state the names and employment status of everyone who stayed at the villas, the purpose of their visits, or the duration of their stays.

Although the contractor personnel and former TFBSO staff we interviewed as a part of our ongoing audit said visitor logs were kept as a part of the operation of TFBSO's villas, we have been unable to locate a comprehensive list of who stayed at the TFBSO villas. Our analysis of the TFBSO hard drive found 23 "travel trackers" that contained information regarding who may have stayed at the villas between September 18, 2010, and July 20, 2012. However, the villas were in operation until December 31, 2014, and we were unable to find any information among the documents on the hard drive that showed who stayed at the villas from July 21, 2012, to December 31, 2014, the last 2 and a half years the villas were in operation. For the period between September 18, 2010, and July 20, 2010, the spreadsheets include the names of individuals staying at the TFBSO villas, but not the purpose of the visit or, in many cases, who the visitor worked for (see enclosure I).

We also requested that Triple Canopy, DGI, and MNBE provide rosters of all residents and visitors to the TFBSO villas, but the contractors reported that they did not have this information. Although all of the contractors provided lists of contractor employees who worked on the TFBSO villa contracts, the lists did not contain any information that would identify whether the employees actually stayed at a villa. However, our interviews with contractor personnel and former TFBSO staff indicate that at least some security personnel and site managers lived in the villas.

Beyond providing a list of employees who worked on the TFBSO villa contracts, DGI noted in its July 2016 response to us that during the execution of its contracts, "Operational security concerns for traveling VIP's led to coordination of such travel directly between the on-site performers with the customer [TFBSO] and travelers," and that there was no regular communication between DGI staff in the United States and Kabul regarding who would be visiting ahead of time. In that response, DGI stated that it would search its archived emails for further information, but reported to us on September 9, 2016, that it could not locate any additional records.

Finally, we reviewed all available contract files for information detailing who stayed at the villas, the purpose of those visits, and the duration of any visits, but we could not find any further relevant information.

2. A breakdown of the costs incurred by TFBSO to operate, furnish, and maintain these villas.

On November 25, 2015, our Office of Special Projects reported that DOD spent nearly \$150 million on private housing and private security guards to support TFBSO's operations in Afghanistan. We derived this figure from information provided by legal representatives for Triple Canopy, DGI, and MNBE. Based on our analysis of the TFBSO hard drive obtained on January 14, 2016, contract documents retained by relevant U.S. contracting agencies, and discussions with the contractors regarding their operation of TFBSO's villas, we concluded that \$183,213,210 was obligated to 13 contracts or delivery orders that partially or fully supported TFBSO's villas in Afghanistan. However, because the documentation is either incomplete or does not contain enough detail to delineate villa costs versus non-villa costs, we could not identify an exact amount.

We cannot state definitively exactly how much was spent on the villas under these contracts because the files for four of the contracts were incomplete. Furthermore, some of these contracts included additional tasks that did not directly involve operating, furnishing, and maintaining the villas. For example, under DGI contract number D10PD18556, worth \$32,331,287.83, in addition to providing logistics, security, and life support services for the villas, DGI was required to provide "project management" and "specialized technical support," including consultants with expertise in Afghanistan's culture, politics, and business environment. These subject matter experts would "provide in-country assessment of the business environment including: security risk, infrastructure suitability, water, power, raw materials, transportation, communications, education, labor pool, agricultural situation, etc." Because the costs in this contract were not broken out by activity, we cannot ascertain how much of the \$32,331,287.83 was spent on supporting the villas and how much was spent on other contract activities. See enclosure II for a breakout of obligations by contract according to each contract's closeout documentation or final costs as reported by the contractor.

For 4 of the 13 contracts or delivery orders, we could not determine the final obligated amount because the U.S. contracting agencies were either unable to locate the contract closeout documentation, or the contract documentation purportedly had been disposed of in accordance with normal agency procedures. Specifically, DOD's Washington Headquarters Service (WHS) could not locate closeout documentation for two of the contracts it administered: contract numbers HQ0034-11-C-0031 and HQ0034-13-C-0101. The General Services Administration could not provide closeout information for contract number GS-07F-5499R, delivery order number GST1110BJ8012. Additionally, the U.S. Air Force Acquisition Directorate notified us that it could not locate some TFBSO contract files, including files for contract number FA7014-09-F-A148, possibly because it had disposed of them in accordance with its contract retention policies and procedures.

For all contracts that lack closeout documentation, we have included in enclosure II the obligations data provided to us in 2015 and each contract's original obligation amount or final costs as reported by the contractor, as available.

Additionally, we asked Triple Canopy, DGI, and MNBE for contract and cost information. Based on our review of the contracts, cost information provided by the contractors, and information previously provided to SIGAR's Office of Special Projects, we determined that:

- Triple Canopy was paid at least \$67,485,357 for contracts related to TFBSO. Triple Canopy's response to us was composed of four electronic folders of contract documentation that lacked information relevant to the villas. We followed up with Triple Canopy on August 19, 2016, and interviewed the company's legal representative on September 8, 2016. During this call, the legal representative said Triple Canopy had provided some documentation to our Office of Special Projects within the past 2 years, and finding any additional documents related to the contract's costs would be difficult because Triple Canopy was not legally required to maintain such documentation.
- DGI was paid at least \$51,560,064 for contracts related to TFBSO. DGI reported that it paid \$827,745 in Kabul for rent for the villas between November 2009 and September 2011. DGI also reported spending \$113,400 on rent for a villa in Herat between May 2010 and June 2011. Additionally, DGI provided two documents containing a large amount of financial information that they said represented all payments made to subcontractors or "non-employees" of DGI. However, these documents did not provide information detailing the types of services rendered by these subcontractors and "non-employees," and also did not provide contract costs incurred directly by DGI. DGI officials said the contracts had multiple components and that the company would not be able to break out costs related to the villas from other, non-villa-related costs associated with each contract. Therefore, the documents and other information DGI provided do not give a full picture of what it spent on the villas.
- MNBE was paid at least \$64,167,788 for contracts related to TFBSO. MNBE provided the most
 detailed response to our request for a breakdown of the costs associated with operating and
 maintaining TFBSO's villas. See enclosure III for a summary of MNBE's costs for the villas by contract.
- 3. Descriptions of the various types of villas TFBSO used. For example, your November 25 inquiry letter refers to "leadership villas" and "investor villas." How did these villas differ from one another and what might have been more basic villas? How did TFBSO decide who would occupy each type of villa?

Based on our analysis of the TFBSO hard drive, the contract files, and information Triple Canopy, DGI, and MNBE provided, we could not find a documented distinction between the "leadership villas" and "investor villas" or identify the specific villa to which these terms referred. In fact, none of the contracts we reviewed used the term "leadership villa." In addition, we could not find any documents indicating how TFBSO decided who would occupy each type of villa.

The term "villa" appears in several of TFBSO's security and life support contracts, but only Triple Canopy's contracts contained language distinguishing the types of villas. The first time the contracts referred to TFBSO's housing facilities as "villas" was in the March 28, 2011, amendment to DGI contract number D10PD18556. The phrase "investor villa" appears for the first time in the contract files in the amended statement of work for Triple Canopy contract number D12PC00330, awarded on December 23, 2011. However, these documents do not make a clear distinction between the villa types beyond calling for separate office spaces, kitchens, and dining rooms for the investor villas, and requiring upgraded furnishings. The contracts did not specify which villas were for investors or how many there were.

In addition, the December 23, 2011, statement of work for Triple Canopy contract number D12PC00330 calls for an "investor villa" to have "upgraded furniture that is western style hotel accommodations." The statement of work also increased the compound's housing capacity to 43 people, including "TFBSO personnel and/or VIP/Industry professionals who are guests of TFBSO." With respect to differences between the "investor villa" and the villas for TFBSO staff, separate office spaces were required for TFBSO personnel and "Investors/Special Guests." Again, the contracts did not specify which villas were for investors or how many there were.

solicitations, award decisions, justifications (for single-bid contracts and contracts awarded with less than full and open competition), contract audits and reviews, and contractor past performance reviews.

We requested copies of all contract-related documents for the villas from each of the four relevant contracting offices. As previously noted, the U.S. Air Force Acquisition Directorate notified us that it could not find its TFBSO contract files, possibly because it had disposed of them. The General Services Administration provided us with partial files electronically. The Department of Interior and WHS provided us access to all the contract files, but did not give us copies. This is because many of the contract files related to TFBSO villa operations consist of hundreds, if not thousands, of paper pages, making them prohibitively large to scan or photocopy in their entirety. To avoid the burden of unnecessary photocopying, we conducted contract reviews where we reviewed each contract file in its entirety, but only retained copies of relevant information, including closeout documentation. We would be happy to provide copies of the files we retained, upon request. See enclosure IV for a list of the contracting agencies for each TFBSO villa-related contract.

As I said to you in a letter dated June 3, 2016, DOD's records for TFBSO are incomplete.¹ In fact, in response to a separate congressional request, we attempted to perform a full financial audit of TFBSO's activities in Afghanistan. Because DOD could not produce the basic contract files and other financial information related to TFBSO's expenditure of the \$640 million in appropriations it received, we determined that it would be impossible to conduct a full financial audit that would allow us to express a meaningful opinion on TFBSO's financial records.

I am submitting this letter to you pursuant to my authority of Public Law No. 110-181, as amended, and the Inspector General Act of 1978, as amended. We continue to make inquiries to DOD, the contracting agencies, TFBSO's contractors, and former task force employees as part of our ongoing audit of TFBSO activities in Afghanistan. If we obtain any new information on the villas, we will update your office. 

Dear Special Inspector General Sopko,

I read SIGAR's November 25, 2015 inquiry letter to the Department of Defense with great interest and concern. I am particularly concerned that the Department of Defense's Task Force for Business and Stability Operations (TFBSO) may have been able to save millions of taxpayer dollars by operating from U.S. diplomatic or military facilities in Afghanistan instead of renting private "villas" in Kabul and other locations throughout the country.

To help determine the costs and benefits of TFBSO's decision to use private housing in Afghanistan, I am requesting that SIGAR obtain the following information, either from the Department of Defense or the relevant contractors, and provide it to my office:

- (1) The names and employment status (for example: TFBSO staff member, other government agency employee, contractor employee, or TFBSO guest or visitor) of all persons who stayed at these villas while they were leased by TFBSO, the purpose of their visit, and the duration of their stay.
- (2) A breakdown of the costs incurred by TFBSO to operate, furnish, and maintain these villas.
- (3) Descriptions of the various types of villas TFBSO used. For example, your November 25 inquiry letter refers to "leadership villas" and "investor villas." How did these villas differ from one another and what might have been more basic villas? How did TFBSO decide who would occupy each type of villa?
- (4) Copies of all contract-related documents pertaining to services at the villas provided by Triple Canopy, Defense Group Incorporated, and Muscogee Nation Business Enterprise. "Contract-related documents" includes contracts, delivery and task orders, modifications and amendments, as well as contract proposals, solicitations, award decisions, justifications (for single-bid contracts and contracts
