**SUBJECT:** Performance Audit of Incurred Costs for ICF Macro, Inc., for Fiscal Year 2019

This memorandum transmits the final performance audit report on incurred costs submission (ICS) for ICF Macro, Inc. for Fiscal Year (FY) 2019. The U.S. Agency for International Development (USAID) Office of Acquisition and Assistance, Cost, Audit and Support Division, Contract Audit Management Branch contracted with the independent certified public accounting firm of Tichenor & Associates, LLP (Tichenor) to conduct the audit. Tichenor stated that it performed its audit in accordance with government auditing standards issued by the Comptroller General of United States. Tichenor is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on whether costs claimed by ICF Macro, Inc. in the FY 2019 ICS are accurate, allowable, allocable, and reasonable in accordance with contract terms and applicable Government acquisition regulations. The audit's objective was to determine whether the costs claimed by ICF Macro, Inc. in its FY 2019 ICS were accurate, allowable, allocable, and reasonable in accordance with the ICF Macro, Inc.'s USAID contracts and applicable Government acquisition regulations, specifically the Federal Acquisition Regulation (FAR), the USAID Acquisition Regulations (AIDAR), Federal Travel Regulations and/or the Department of State Standard Travel Regulations (DSSR), and Buy-American Act for the contracting officer to execute the finalization of allowable contract costs and indirect rates for the fiscal year with ICF Macro, Inc. To answer the audit's objective, Tichenor designed its testing procedures to review the incurred costs reported by ICF Macro, Inc. for FY 2019 and reconciled it to its general ledger, and other records and documentation to determine its adequacy for audit purposes. Further, Tichenor reviewed applicable rules, regulations, guidance, and ICF Macro, Inc.'s policies and procedures regarding claimed direct

and indirect costs. Tichenor examined USAID incurred costs of \$40,774,241 for FY 2019.

Tichenor concluded that ICF Macro, Inc. prepared its FY 2019 ICS in accordance with applicable Government acquisitions regulations of the FAR, the AIDAR, and the DSSR regarding accuracy, allowability, allocability, and reasonableness of incurred costs and are appropriate for the Contracting Officer's use in executing the finalization of allowable costs and indirect rates for the fiscal year with ICF Macro, Inc. Tichenor did not identify any questioned costs. Further, Tichenor noted that ICF Macro, Inc. may have overbilled USAID \$8,516,763 through FY 2019.
