**SUBJECT:** Performance Audit of Incurred Costs of CDM International for the Fiscal Year Ended January 2, 2021 (3-000-23-069-I)

This memorandum transmits the final performance audit report on incurred costs submissions (ICS) for CDM International for the Fiscal Year (FY) ending on January 2, 2021. The U.S. Agency for International Development (USAID) Office of Acquisition and Assistance, Cost, Audit and Support Division, Contract Audit Management Branch, contracted with the independent certified public accounting firm of Brown & Company CPAs and Management Consultants, PLLC (Brown) to conduct the audit. Brown stated that it performed its audit in accordance with government auditing standards issued by the Comptroller General of United States. Brown is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on whether costs claimed by CDM International for the FY ending January 2, 2021, ICS are accurate, allowable, allocable, and reasonable in accordance with contract terms and applicable Government acquisition regulations.<sup>1</sup>

The audit's objective was to determine whether the costs claimed by CDM International on in-scope awards and subawards for the FY ending January 2, 2021, are allowable, allocable, and reasonable in accordance with award terms; Part 31 of the Federal Acquisition Regulation (FAR); Agency for International Development Acquisition Regulation (AIDAR); Department of State Standardized Regulation (DSSR); and 2 Code of Federal Regulations (CFR) 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards. To answer the audit's objective, Brown (1) identified Government cost-type, flexibly priced, time and material closed contracts and subcontracts for the FY ending January 2, 2021; (2) performed a reconciliation between the adjusted total costs booked and the cumulative amount billed for the FY ending January 2, 2021, and reported any over/under-billings; (3) determined whether contract limitations as reported are appropriate based on costs claimed; (4)

determined whether the cumulative amount billed for each contract, as of the end of the fiscal year under review, exceeded the total funded value on the contract at that point in time; and (5) performed a risk and materiality assessment of CDM International using procedures from newly enacted guidance developed by a Department of Defense Procurement Panel. Brown examined USAID incurred costs of \$20,590,393 for the FY ending January 2, 2021.

Brown concluded that CDM International's costs claimed for in-scope awards and subawards for the FY ending January 2, 2021, are allowable, allocable, and reasonable in accordance with contract terms, Part 31 of the FAR, AIDAR, DSSR, and 2 CFR 200. Brown did not identify any direct or indirect questioned costs or rates. Finally, Brown did not note any instances of material non-compliance with laws, regulations, or contract terms required to be reported under Government Auditing Standards during the FY ending January 2, 2021, audit.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) ("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
