SUBJECT: Financial Audit of USAID Resources Managed by Zambia Centre for

Communication Programmes Under Multiple Awards, January 1 to December 31,

2021 (Report No. 4-611-23-041-R)

This memorandum transmits the final audit report on USAID resources managed by Zambia Centre for Communication Programmes (ZCCP) under the following awards: I) USAID Stop GBV project, cooperative agreement No. 72061119CA00001; 2) Zambia Community HIV Prevention Project (Z-CHPP), sub-award number 260-007202 under PACT Zambia; and 3) Prevention Against Malaria Outcomes (PAMO) Plus Activity project sub-award number AID.583604-01707311-SUB under PATH. ZCCP contracted with the independent audit firm PricewaterhouseCoopers (PwC), Lusaka, Zambia to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards (GAGAS). However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on ZCCP's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate ZCCP's internal controls; (3) determine whether ZCCP complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, PwC (I) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by ZCCP as incurred from January I to December 31, 2021; (2) evaluated the control environment, the adequacy of the

accounting systems, and control procedures that pertain to ZCCP 's ability to report financial data consistent with the assertions embodied in each account of the fund schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. ZCCP reported expenditures of \$6,908,972 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; one material weakness in internal control; and no instances of material noncompliance.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated January 11, 2023.

To address the issues identified in the report, we recommend that USAID/Zambia:

**Recommendation 1.** Verify that Zambia Centre for Communication Programmes corrects the one material weakness in internal control detailed on pages 32 and 33 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
