- **SUBJECT:** Financial Audit of USAID Resources Managed by Right to Care Zambia Limited Under Multiple Awards, October 1, 2021, to September 30, 2022 (Report No. 4-611-23-098-R)

This memorandum transmits the final audit report on USAID resources managed by Right to Care Zambia Limited (RTCZ) under the following awards: 1) subaward Antiretroviral Therapy Simplification - Optimization of Programs and Services (ArtOps)- EQUIP mechanism, cooperative agreement AID-OAA-A-15-00070 under Right to Care NPC South Africa (for the period October I to December 31, 2021 – closeout); and 2) Action to HIV Epidemic Control activity contract 72061121C00006 (for the period October 1, 2021, to September 30, 2022). RTCZ contracted with the independent audit firm PricewaterhouseCoopers, Lusaka, Zambia to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on RTCZ's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate RTCZ's internal controls; (3) determine whether RTCZ complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, PricewaterhouseCoopers (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by RTCZ as incurred from October 1, 2021, to September 30, 2022; (2) evaluated the

control environment, the adequacy of the accounting systems, and control procedures that pertain to RTCZ's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. RTCZ reported expenditures of \$19,338,660 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and no instances of material noncompliance.

Accordingly, we are not making any recommendations.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
