- **SUBJECT:** Financial Closeout Audit of USAID Resources Managed by Nuru Nigeria Under Cooperative Agreement 72062021CA00002, January 1, 2022, to May 20, 2023 (Report No. 4-620-24-073-R)

This memorandum transmits the final audit report on USAID resources managed by Nuru Nigeria under the Building Sustainable Livelihoods in Nigeria program. Nuru Nigeria contracted with the independent audit firm Bakertilly, Lagos, Nigeria to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on Nuru Nigeria's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate Nuru Nigeria's internal controls; and (3) determine whether Nuru Nigeria complied with award terms and applicable laws and regulations.

To answer the audit objectives, Bakertilly (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by Nuru Nigeria as incurred from January 1, 2022, to May 20, 2023; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to Nuru Nigeria's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; and (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards. Nuru Nigeria reported

expenditures of \$980,970 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified \$1,844 in ineligible questioned costs; two material weaknesses in internal control; and two instances of material noncompliance. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation for the related material noncompliance instance. Nevertheless, we suggest that USAID/Nigeria determine the allowability of the \$1,844 in questioned costs and recover any amount determined to be unallowable. In addition, although we are not making a recommendation for significant deficiencies noted in the report as well as the material noncompliance instance reported to be resolved, we suggest that USAID/Nigeria determine if the recipient addressed the issues noted. The audit firm issued a management letter.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated March 14, 2024.

To address the issues identified in the report, we recommend that USAID/Nigeria:

Recommendation I. Verify that Nuru Nigeria corrects the two material weaknesses in internal control detailed on pages 28 to 30 of the audit report.

Recommendation 2. Verify that Nuru Nigeria corrects the one instance of material noncompliance detailed on pages 35 to 36 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential").
