This memorandum transmits the final audit report on USAID resources managed by World Wide Fund for Nature South Africa (WWFSA), Khetha Program – Protecting Wildlife, Benefitting Communities in South Africa and Mozambique. WWFSA contracted with the independent certified public accounting firm Nexia SAB&T, Cape Town, South Africa, to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards (GAGAS). However, it did not have continuing professional education and an external peer review that fully satisfied the requirements of GAGAS. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on WWFSA's schedule of expenditure of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditure of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate WWFSA's internal controls; (3) determine whether WWFSA complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Nexia SAB&T (I) audited the schedule of expenditure of USAID awards for the award including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by WWFSA as incurred from July I, 2020, to June 30, 2021; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to WWFSA's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditure of USAID awards; (3) identified the award terms and

pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditure of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. WWFSA reported expenditures of \$1,896,179 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditure of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified \$38 in ineligible questioned costs; no material weaknesses in internal control; and no instances of material noncompliance. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation. Nevertheless, we suggest that USAID/Southern Africa determine the allowability of the \$38 in questioned costs and recover any amount determined to be unallowable. In addition, although we are not making a recommendation for significant deficiencies noted in the report, we suggest that USAID/Southern Africa determine if the recipient addressed the issues noted. The audit firm issued a management letter as part of the audit report.

Accordingly, we are not making any recommendations.

During our desk review, we noted several minor issues which the audit firm will need to address in future audit reports. We presented these issues in a memo to the controller, dated April 26, 2022.
